Music Generation Dublin City - Resource Worker 5 Year Fixed Term Position Ref: MGRW25

City of Dublin Education and Training Board (City of Dublin ETB) was established on 1st July 2013 under the Education and Training Boards Act, 2013. City of Dublin ETB has 3,000 employees and an annual budget of €580m. It is the state education and training authority for Dublin city and serves the area covered by Dublin City Council. This provision is delivered to over 48,000 learners (20,000 full-time and 28,000 part-time) and is supported by a range of services including a psychological service, a curriculum development unit, a buildings maintenance unit and Head Office staff in Ballsbridge. It also has statutory responsibility for supporting the provision, coordination, administration and assessment of youth work services in Dublin city and is the lead partner for Music Generation Dublin City. City of Dublin ETB is also responsible for the national awarding authority for student grants in Ireland, Student Universal Support Ireland (SUSI).

Music Generation Dublin City is a performance music education programme in Dublin City providing access to a range of vocal and instrumental music opportunities for children and young people in their local area.

Initiated by Music Network, Music Generation is co-funded by U2, The Ireland Funds, the Department of Education and Local Music Education Partnerships (LMEPs). Locally, Music Generation Dublin City is supported and funded by City of Dublin ETB and Dublin City Council.

Location of Position	The position will be based in 70 Morehampton Road, Donnybrook, D04x797.
Salary	Starting pay will be at the minimum point of the Youthreach Resource Person salary scale, €37,034. This is not negotiable. An incremental salary scale applies thereafter. Previous public sector experience may be eligible for incremental credit, to be determined upon appointment.
Annual Leave	22 working days per annum (pro rata).
Hours of Work	35 hours per week.
Reporting	The successful person will report to Kieran McGuinness.
Details of Position	This is a fixed term contract to work alongside the MDO and Admin as part of the Music Generation team.
Essential Requirements	 One year experience working with adults or children in an educational or community development setting. One year administrative or course management experience
Desirable Requirements	 At least Level 7 on the NQF in one of the following areas: Education, Community Development ore in a relevant discipline(s) commensurate with his/her role. Experience in class instruction and peer development/ teaching. Experience in group facilitation. Experience working with community and statutory partners in the area of education. Experience and understanding of Music Generation. Experience coordinating classes and supporting peers.

	 Responsibility to the MDO / Admin on a day to day basis for supporting the delivery of the Community Education Programme. Deputise for the MDO / Admin as required. Tutor and learner support, initial assessment, ILP, progression, evaluation etc. Work with the management and staff in the planning, delivery and evaluation of appropriate responses to education and training needs, including the identification and implementation of indicators for education and training outcomes for learners and groups.
	 Support outreach work by engaging with external stakeholders to identify local education and training needs, representing the interests of City of Dublin ETB. Engage with internal stakeholders including the Guidance Service and Literacy Service to ensure progression pathways are visible to learners. Promotion of the local service and of the City of Dublin ETB.
	 Work with the programme management and staff team in organising events that support the programme delivery, enhance the profile of the service, centre or CDETB, and / or celebrate learner / group achievements. Support the monitoring of learner attendance, participation and community group
	 support. Deliver specific workshops / one-off sessions to learner groups that complement the programme including specific information sharing and facilitation to support identification of progression routes.
	 Implement data management processes including, as required, Programme Learner Support System (PLSS), the Quality Assurance processes and other CDETB programme specific systems.

Terms & Conditions of Appointment	 The appointment will be subject to the sanction of the Chief Executive. Any offer will be subject to the receipt of two satisfactory references. The appointment will have a probationary period, details of which will be stipulated in the contract of employment. Appointment is to City of Dublin ETB as a whole, not to a particular centre. City of Dublin ETB reserves the right to transfer staff as the needs of the organisation dictates. The person appointed to the post will be required to contribute to the relevant Superannuation Scheme. For the purposes of satisfying the requirements as to health it will be necessary for the successful candidate before they are appointed, to undergo at City of Dublin ETB's expense, a medical examination by a qualified practitioner nominated by City of Dublin ETB. External work may not be undertaken without the prior consent of City of Dublin ETB.
Citizenship Requirements	Candidates should note that eligibility to compete for posts is open to citizens of the European Economic Area (EEA) or to non-EEA nationals with a valid work permit. The EEA consists of the Member States of the European Union along with Iceland, Liechtenstein and Norway. Swiss citizens under EU agreement may also apply. Termination	The appointment will be terminated by one month's notice in writing on either side.
Garda Vetting	City of Dublin ETB is registered with the National Vetting Unit (NVU) which provides a disclosure service for organisations who have staff positions which may involve regular unsupervised access to children and vulnerable adults. As part of the organisations recruitment and selection process, offers of employment will be subject to NVU disclosures, where applicable. City of Dublin ETB reserves the right to re-vet all staff employed in positions that entail working with children and vulnerable adults at any time during their employment.
Sick Leave and Special Leave	Sick leave and special leave may be allowed in accordance with the conditions in force for the time being for staff employed under the Schemes of Education and Training Boards.
Superannuation & Retirement	The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil/Public Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at www.singlepensionscheme.gov.ie . Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or

	 special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history. Key provisions attaching to membership of the Single Scheme are as follows: Pensionable Age: The minimum age at which pension is payable is 66 (retirement age is linked to State Pension Age). Retirement Age: Scheme members must retire on reaching the age of 70. Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI). Post retirement pension increases are linked to CPI.
Pension Abatement	If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension will be subject to abatement in accordance with Section 52 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. Please note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position. However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular 7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013, any of which renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.
Department of Education Early Retirement Scheme for Teachers Circular 102/2007	The Department of Education introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).
Exclusions	Candidates should note that persons who have taken part in Public Service early retirement schemes including the following are not eligible to take part in this competition: Incentivised Scheme for Early Retirement (ISER): It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in the Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the <i>same employment or the same sector</i> . Therefore, such retirees may not apply for this position. Department of Health and Children Circular (7/2010): The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for reemployment in the public health sector or in the wider public service or in a body wholly or mainly funded from public funds. The same prohibition on re-employment applies under the VRS, except that the prohibition is a period of 7 years, after which time any reemployment will require the approval of the Minister for Public Expenditure and Reform.
